I further agree to defend and indemnify the Company against and in respect of all losses, costs, expenses, liabilities or damage, including counsel fees reasonably incurred in defending or resisting any claims, actions, demands, debts, damages, and obligations of any nature, whether arising in contract, tort, by statute, or at common law, known or unknown arising out of, or relating to any claims whatsoever whether asserted by myself, my child(ren) or other minor child(ren) even if those claims are based on the actions, omissions, or negligence of the Company, its employees, agents, and represent representatives.

I also understand that Company may photograph, videotape or otherwise memorialize my activities, the activities of my minor child(ren) or others minor children accompanying me, and I hereby grant my consent to the same to the Company's use of the likeness, photograph or videotape in its endeavors which may include advertisement materials, social media, and/or commercials and release to the Company any rights in said likeness, photograph, or videotape of either myself, my child(ren) or other minor child(ren).
